Timelines and Process for the election:

- The nomination form should be submitted at the office of the Principal of St. Columba's School. (As per Bye-Laws the Principal is the Patron of the OCA as well as the competent authority for the conduct of elections of office bearers and executive committee of OCA.)
- The last date for the qualified persons to file their nominations is MONDAY, 10th November, 2025 by 1.30 pm (school working hours).
- The last date for withdrawal of nominations is Friday, 14th November, 2025 by 1.30 pm (school working hours).

The final list of the contestants shall be communicated thereafter.

For the reference of the members:

- The Executive Committee shall comprise of 15 members
- Three Office Bearers : President, Secretary and Treasurer
- Nine Elected members
- Two members nominated by the Principal
- Immediate Past President

The tenure of the committee shall be 2 years

The members seeking elections for the post of office bearers should not be less than 30 years of age.
